Based on the orders dated 11.08.2023 of the Hon'ble High Court of A.P., Amaravati in W.P.No. 18190 of 2023, the Government of Andhra Pradesh, Amaravati has issued orders duly extending the period of Recognition from 3 years to 8 years in respect of Private Aided and Unaided Schools to which Recognition has already been accorded by the competent authority for a period of 03 years in the reference (6) read above. Accordingly, the Commissioner of School Education, A.P., Amaravati has communicated the same to take further necessary action accordingly in the reference (7) read above.

The Correspondent, Sri Chaitanya School, Reddypalem, Guntur, Guntur District has submitted the proposal for extension of the recognition period of the school from 03 to 08 years in the reference (9) read above.

The undersigned who is the competent authority after careful examination of the proposals and the conditions prescribed in the references (1) to (4) read above and as per the instructions issued by the Government / Commissioner of School Education, Andhra Pradesh,

Amaravati in the references (6) & (7) read above and in continuation of this office reference (5) read above, the Regional Joint Director of School Education, Guntur is pleased to extend the period of recognition for a period of 05 years from 2025-26 to 2029-30 to classes VI to X (E.M) in respect of Sri Chaitanya School, Reddypalem, Guntur, Guntur District without aid now or in future.

The Deputy Educational Officer, Guntur, Guntur District is instructed to obtain the required documents from the management of school concerned every year and submit the same to the District Educational Officer, Guntur without fail. However, by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the instructions issued in reference (5) read above.

Any deviation of the above, action will be initiated against the management of the school and informed that the Recognition now accorded will be withdrawn without assigning any reasons thereof.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submitting the application for Renewal of Recognition for the year 2030-31.
